- Review new and renewal proposals and work with AJWS partners to monitor grants through reviewing reports, site visits, meetings, correspondence and oversight evaluations;
- Recommend ways to strengthen the capacity of AJWS partners through the identification of opportunities for training, technical assistance and evaluation;
- Coordinate grantee meetings and exchanges and provide timely reports and assessments of these meetings;
- Produce grantee related information for AJWS board, departments and other stakeholders;
- Keep AJWS apprised of general political and economic trends in Haiti and any newsworthy items as they impact our project partners or program focus;
- Represent AJWS at conferences, forums, and meetings; and
- Coordinate administrative needs of the portfolio.

- BA/BS required; Master's degree in a relevant field preferred;
- Minimum five years experience working in community development and/or human rights focusing in particular on the needs of women, youth and/or sexual minorities in Haiti;
- Ability to work with diverse communities and in remote areas throughout Haiti;

- Strong grasp of social-political, economic context of Haiti and familiarity with current political, social and economic trends in the Latin America region;
- Strong oral and written communication skills in English and Kreyol, French/Spanish a plus;
- Familiarity with monitoring and evaluating budgets;
- Working understanding of human rights norms and practices, global development theory and grassroots social movement building;
- Team player and flexible about the challenges of working in a fast-paced environment with shifting priorities;
- Highly organized, with the proven ability to work independently, prioritize and complete multiple projects, meet deadlines, and maintain consistent attention to detail;
- Experience with, and commitment to, social justice and human rights movements;
- Commitment to and passion for the work of AJWS.
