

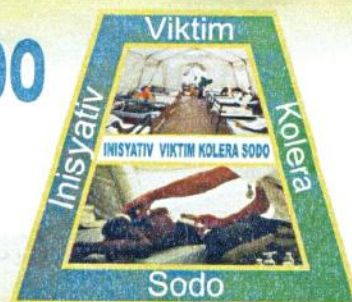

Dear Excellency,

I greet you in the name of my country and I congratulate you for what you have done and all you will do to help the cholera victims find justice and compensation according to the International Declaration of Human Rights.

My name is Yolène Gracia and I am twenty-nine years old. I live in Gros Pied, Saut D'Eau, Haiti. I have a child, Djoudeka Charles, who fell ill with cholera in November of 2011. He had a stomachache and a headache, vomited, and had diarrhea. I took him to a health clinic where he spent four days. I had no money to take him to the hospital but borrowed some from a neighbor at two o'clock in the morning. The cholera left him with vertigo.

I ask you to help me secure justice and compensation and I thank you for your understanding.
