What caused me to lose my common sense is because I vomited a lot and I had diarrhea. I spent 3 days without being able to eat. My child had to use a charter to take me to the hospital.

Ever since I caught the disease, I lost my eyesight. MINUSTHA has spread this disease in Haiti. I am asking for Justice and Restitution for all the cholera victims, especially for myself.





Your Excellency,

I greet you on behalf of my country and I am congratulating you for the work that you do, and that you will continue to do, to help the cholera victims receive justice and indemnity according to my country's law and according to international law for human rights.

They call me Souffrant Marirose. I am 36 years old. I live in Grand Ravanne, in the first section of the Saut D'Eau commune. I had cholera in the month of May 2011. They took me to the Saut D'Eau cholera treatment center while I was extremely suffering. I also had a stomach ache, vomiting, and diarrhea. This illness they call cholera came to take me to the "Peyi san chapo"¹. I spent three days and two nights sleeping on a hospital bed. Thanks to the support of the nurses and doctors, the good Lord made me well enough to be released. However, despite that I still have a lot of pain in my body.

I am asking for you to help me receive justice quickly and indemnity. Thank you for understanding us and our intentions.


Today is a big day for me, as I get this opportunity to write the U.N. Security Council's President and members. I take the opportunity to salute you.
