





My name is Orelyen Pierre. I am a victim of cholera. The sickness first affected me while I was in the field. When it struck, I stopped being able to walk. I began to vomit and have diarrhea uncontrollably. I lost the ability to speak. They brought me to a health center where I spent three days taking oral and intravenous serum. Afterwards they transferred me to a hospital where I spent seven days.

To pay for all of this, I had to sell two goats and one cow. And as if that wasn't enough, I developed hemorrhoids, which means I am still paying money to treat my illness. For these reasons, I demand that the United Nations Security Council with the Martelly-Paul government help me and all cholera victims in Haiti find justice and compensation.






President I am really glad today to writing you this letter, and I take this opportunity for me to greet you, my name is Mervil Osnel I live Otovan, I am 40 years.
