



Your Excellency,

It is a privilege for me to write to you and to thank-you for your courage and understanding, and I would like to take advantage of this opportunity by addressing all of the members of the United Nations Security Council on the issue of reparations for all of the cholera victims in Haiti.

My name is Pierre Mondely. I am twelve years old and I live in the region of Dibison, in the communale section of LaSel, in the commune of Saut-d'Eau. I got cholera on April 3rd 2011, during which time I had diarrhea, vomiting, and was so severely dehydrated that I could not get out of bed. They rushed me to the Emergency Room at the Mirebalais hospital. After four days I returned to my house but after this sickness I still feel dizzy and disoriented.

I am counting on you, my dear Excellency, to make my request a reality, and I thank-you for your empathy and your collaboration.



Mr. President,

I greet you in the name of my country and I congratulate and thank-you for the work that you have done and all that you will do further still to help the victims of cholera obtain reparations, according to the principle of law of my country and the International Treaty on Human Rights.

They call me Marieta Louinice. I am 61 years old and I live in the region of Fos Lana, in the communale section Lasel, in the commune of Saut-d'Eau. I had the Nepalese cholera in the month of June 2011. They brought me to the Mirebalais Cholera Treatment Center, as I was under great suffering; my stomach hurt, and I had severe diarrhea and vomiting. This illness turned into a violent poison and led to me a state of chills. I spent two days in the hospital bed. Thanks to the help of doctors, God, and medication, the Lord cured me, but to this day the illness has left me with some pains, such as occasional headaches and stomachaches.

Mr. President, I know that in all countries with serious democracies, justice is an affair where the state must respect the law and human rights in order for the people to be able to live on the earth.

Mr. President, as our country and the organization your direct, together with all of the other institutions of human rights law in the world, know that it was the MINUSTAH Nepalese soldiers who brought us cholera in the country of Haiti, I am asking you, along with the members of the United Nations Security Council to help me seek reparations and justice.

I thank-you in advance while I hope this time that the Security Council will help me and all of the cholera victims in the country of Haiti obtain personal justice.



Today is an important day for me as I take this pen to write you this letter, because I want all of you to know how the cholera epidemic ravaged us all so much.

My personal identification number is : 06.06.99.1992.08.00048. I live in the region of La Fem, in the communale section La Sel, in the commune Saut-d'Eau.

I have a child who is named Denosyer Zidane Andowal, who was five months old.

On February 4th, 2014, he came down with cholera, which caused him many serious ailments, like severe diarrhea, a distended stomach, and dehydration. I immediately ran with him to the Mirebalais Cholera Treatment Center (CTC) in order to find a cure for him. He spent four days in the cholera center before he was better, but since that moment, he has suffered from other ailments, like prolonged weakness in his arms and legs.

Mr. President, I know that your organization is the only one in the world that is working to defend the human rights and dignity of all living people, and renders justice for everyone without discrimination, I am asking you along with all of the members of the United Nations Security Council to help me obtain justice against the injuries of cholera because our country did not have cholera before. It was the Nepalese soldiers from MINUSTAH who brought it to us and to this day everyone who was a victim of cholera still carries lasting effects of the malady in their bodies.

I thank you in advance, your Excellency, because you will work to enable me and all the other victims of cholera to obtain justice and reparations.



Today is a great day for me as I write to you, since I want to explain to you how the cholera epidemic damaged me very badly.



To Honorable Secretary General Of The UN: It is with profound sadness that I'm writing this statement to acknowledge human rights and dignity for all. My name is Eles Tinelien. I reside at Dalon section located at Crochu Komin Tamazo. During one night I suddenly felt ill which came upon me. I've vomited along with heavy bouts of diarrhea. I've lost consciousness for two days. Even public transportation didn't want me as one of their passengers to take me to the nearest hospital because I was so ill and afraid I may pass out in their vehicle. When I arrived at the hospital, I received immediate medical treatment and was administered IV treatment. I've spent four days being hospitalized due to the cholera illness and the MINUSTAH soldiers disposing their feces in the riverbanks, which the Haitian people in the countryside and Haitian citizens have this illness of, cholera and this is why I'm requesting reparations and justice. Thank you.
