The attached "Memorandum of Law on Firm Resettlement: Focus on Haitians in Brazil" is being provided to you by the Northwest Immigrant Rights Project in case you would like to submit it to the Immigration Judge to consider in your case if you do not have a lawyer. It is not specific to your case, but explains how the firm resettlement laws might apply in a variety of cases for Haitian citizens who were living in Brazil. It is not required to submit this document, but we believe it may be helpful.

Note: If you had permanent residence in Brazil (or any other country aside from Haiti) before coming to the U.S., the conclusions in this *Memorandum* might make your judge decide that you have received an offer of firm resettlement. However, we believe that many people should at least qualify for one of the exceptions to the bar, so be sure to tell the judge any relevant information about your individual situation in Brazil (as discussed in the Questions and Answers sheet, provided separately).

## Instructions for filing documents with the Immigration Court and ICE Office of Chief Counsel:

When you want to file documents for the Immigration Judge to consider, you must include a cover sheet with your name and A#, and table of contents.

Send the documents to both the judge and to ICE's attorneys. Ask your pod officer for two envelopes and postage. Mail each filing in a separate envelope to the following addresses:
