Position of the Bureau des Avocats Internationaux (BAI) on the socio-political situation of the

country

The Bureau des Avocats Internationaux (BAI), in the context of it its mission to defend the marginalized populations,

especially the Victims of Cholera of the United Nations Stabilization Mission in Haiti (MINUSTAH), as well as

women and girls who are victims of rape and sexual harassment and victims of repression for exercising their civil

rights, is carefully following the evolution of the country's socio-economic crisis which unleashed a popular mass

uprising against the extreme right "Tet Kale" regime from July 6 to July 9, 2018 and is continuing today.

We should remember that the popular uprising took place shortly after the Moise-Lafontant administration decided

to raise gas prices once again. The decision is not out of line with several other criminal decisions the government has

already taken, such as the criminal government budget of 2017-2018, opposing the minimum wage increase for factory

workers, burying the report of the PetroCaribe scandal, trampling on justice, firing more than 1000 people in OAVCT,

etc.

BAI recalls that the Moise-Lafontant administration has always taken these criminal decisions with much

arrogance, and especially with indifference and contempt of the legitimate protests of the population. At times, they

treat the people like a joke, as with telling them about the fuel price rise, when they don't raise the minimum wage,

and when they fire people in public administration: it is good for the people, it is the government's love for the people

that makes it act against them so. While on the other hand they create more opportunities for the elites' business, that

already do not pay taxes, smuggle and have import tax exemptions, to prosper. For example, the Moise-Lafontant

administration took advantage of the people's passion for soccer and through no bid contracts, purchased hundreds of

flat-screen TVs from elite businesses, and under the pretext of the country's infrastructure problems, tens of millions

of US dollars of heavy construction equipment, when the state could have acquired the equipment from the National

Center of Equipment (CNE).

The BAI salutes the political maturity of the Haitian people who understand that the trademark of this government,

especially the extreme right Tet Kale regime, is to defend the interests of the Syrian-Lebanese bourgeoisie against the

marginalized population. This of course creates additional misery and suffering amongst the disadvantaged majority,

who fully understand what this "squeeze and suck" system of the bourgeoisie and the rotten government means.

BAI is surprised to see the Moise-Lafontant administration, the bourgeois anti-national merchants, and some

shameless intellectuals who are enabling the "squeeze and suck" system of Petion, continue to pretend and ignore the

reality of social inequality, when what they want is to make people believe that there are hidden hands behind the

population's rebellious movement against this system of massive social exclusion. This is done with the perpetuation

of a false narrative: the people are not really in misery, there is not really massive unemployment, there is not really a

healthcare problem, the population's children can go to school free of charge, and there is no hunger.

BAI condemns the cynical behavior of the shameless intellectuals and traditional politicians who continue to ignore the real complaints of the masses, and attempt to dismiss the anger and frustration of people who have been exploited for more than 200 years. These agents must understand that an unstable society that is based on violence, hunger, and misery, will inevitably produce even more chaos and destruction.

BAI understands that those who benefit from the "squeeze and suck" system would never care to try to understand the reasons why the people use these radical methods to make their claims, when we consider that this is a system that is on such a road to ruin that we need to rebuild from scratch.

In this way, BAI will close by asking the Haitian people to resist these ideologies that make them think that protests equal violence and keep mobilized to defend their rights, to fight for social change and to live as the human beings in a society without repression. We ask progressive lawyers and human rights organizations who fight with the oppressed, such as BAI, who believe in respecting Article 28 of the Constitution that guarantees the respect and freedom of public liberties, to provide legal assistance to all victims of state actors who target engaged citizens and activists in the poor neighborhoods to repress the people's rebellion against this right-wing, extremist, "Tèt Kale" regime.
