The work addresses issues related to elections, political violence, and foreign interference, and other obstacles to true democratic governance, through information dissemination, stakeholder engagement, mobilization, and coalition work. This work has been especially crucial in the context of Haiti's ongoing governance crisis associated with a corrupt, repressive, unconstitutional, internationally-supported regime that has systematically dismantled the country's democratic institutions over the past decade.
