

## Electoral Pact

Article 7 I recognize equally that the United Nations brought cholera to Haiti. During the electoral campaign I will denounce the misconduct of the United Nations that does not want to take responsibility. When I am elected I will fight to force the United Nations to take responsibility to compensate all victims of cholera. But I will also participate in pushing the Haitian State to put in place infrastructure for health services and drinking water.

Article 8 I commit and I will work for Haiti to reclaim the rights of its forefathers, meaning that the country of papa Dessalines shouldn't be occupied for any reason.

Article 9 If I win the election, I promise to return to the community periodically and every time the community asks to sit down to talk with the people. I will keep them informed on every action and decision I will take in my post.

Article 10 If I am not elected, I will do the same. I will continue to work in the community so I can gain the confidence of the electorate in another election.

Article 11 If I don't respect this commitment, I will not return to ask the community to vote for any government office.

### FIRST ISSUE

#### WE RECOGNIZE AND WE AGREE ON THESE POINTS

The Haitian state has an obligation to respect people's rights and dignity regardless of their economic or political beliefs.

Haiti signed and ratified an International covenant on political and civil rights (ICCPR) on 6 February 1991, an International covenant on how to establish economic, social, and cultural rights (ICESCR) on 31 January 2012, and an International covenant on children's rights on 8 June 1995.

People's dignity is something they are born with, no one can negotiate it. Political and government programs can change, but people's dignity never changes, it stays the same all the time regardless of where in the country.

People's rights are indivisible and inalienable. Everyone must live equally without discrimination regardless of race, political ideology, color, sex, sexual orientation, handicap, etc...

We recognize that the State cannot give priority only to civil and political rights, because that cannot justify where people are coming from in poverty and misery.

We recognize all obligations that the Haitian government has regarding the respect, promotion and protection of people's rights. These obligations do not mean charity, nor good deeds, they sit on legal bases in accordance with the International human rights treaties and the Constitution of 1987.

## Electoral Pact

I, ....., candidate for the office of ....., recognize and commit to respect the rights to education and health as they are enshrined in the Constitution of 1987 and all treaties and conventions signed and ratified by Haiti.

Article 1 I recognize that education rights are rights that everyone has, I will respect and I will have respect for this right that is in article 22, 32, 32.1, 32.2, 32.3, etc. under the Constitution of 1987 and article 13, 14, and 15 in the International Covenant on Economic, Social, and Cultural Rights (ICESCR) for all children to enjoy these rights.

Article 2 I recognize that health rights are rights that everyone has, I will respect and have respect for this right that is in article 19, 23 of the 1987 Constitution and article 12 in the International Covenant on Economic, Social, and Cultural Rights (ICESCR). When I am elected, I will try like Jean-Jacques so that all Haitians can enjoy their health rights and during the period of my mandate, my biggest priority will be construction of health centers and hospitals.

Article 3 I recognize that all children must obtain necessary medical assistance and health care. The right to go to school is fundamental, free primary school is fundamental and obligatory.

Article 4 During the electoral campaign I will emphasize that health and education rights must be respected, as a way to tell this generation that one person's rights do not work without others'.

Article 5 I commit that during my campaign I will promote health and education rights, when I am elected I will work like Jean-Jacques to respect the rights for everyone to go to school and to get good health care.

Article 6 I agree and I recognize that the rule of the game is democracy, human rights and dignity, and because of that, I agree to conduct my campaign in the framework of programs that respect the dignity and rights of people. If I am elected, I will conduct this mandate with respect for rights and dignity of people.
